**POLL RESULT OF SPECIAL GENERAL MEETING
HELD ON 18 JULY 2024**

Reference is made to the circular of Emperor Entertainment Hotel Limited (“**Company**”) dated 3 July 2024 (“**Circular**”) setting out, inter alia, the notice of the special general meeting of the Company (“**Notice**”) held on 18 July 2024 (“**SGM**”). Capitalized terms used herein shall have the same meanings as defined in the Circular unless the context otherwise requires.

The Directors, namely Ms. Luk Siu Man, Semon, Mr. Wong Chi Fai, Ms. Fan Man Seung, Vanessa, Ms. Lai Ka Fung, May and Mr. Yeung Man Sun, attended the SGM in person or by electronic means. The Company has appointed Tricor Secretaries Limited, the Company’s Hong Kong branch share registrar, to act as the scrutineer for the purpose of vote-taking at the SGM. The poll result of the Resolution proposed at the SGM is as follows:

The Board is pleased to announce that as more than 50% of the votes were cast in favour of the Resolution, the Resolution was duly passed by the Independent Shareholders as an ordinary resolution.

As at the date of the SGM, the total number of issued Shares was 1,188,490,983. As stated in the Circular, Dr. Yeung and his associates (including Emperor Entertainment Hotel Holdings Limited), holding 851,353,645 Shares (representing approximately 71.63% of the total issued Shares and entitling them to exercise control over the voting rights of such Shares), were required to and did abstain from voting on the Resolution at the SGM. Therefore, the total

number of Shares entitling the Independent Shareholders to attend and vote for or against the Resolution at the SGM was 337,137,338 (representing approximately 28.37% of the total issued Shares). Save as the aforesaid, there is no other restriction on any Shareholder to cast votes on the Resolution.
